MEMBERSHIP CATEGORY

Business/Industry: Membership shall be limited to companies or individuals that are engaged in the manufacture, research, development, supply of products and the sale of products or processes based on bioscience products or research.

Associate: Persons or organizations who supply/provide services to bioscience organizations and whose principal business is not in the bioscience sector. This may include organizations that promote public or educational programs of charitable character; post-secondary institutions, teaching hospitals, research institutes and other not-for-profit agencies.

All the employees of business/industry members or associate members are eligible to participate in the Association training programs and industry events.

Business/Industry VOTING MEMBER

Representatives from business/industry members may seek BAM Board of Directors nominations and have voting privileges at the BAM Annual General Meeting.

Membership fees are determined by the number of employees a company has across Canada and/or revenue.

Associate NON-VOTING MEMBER

Not entitled to receive notice of, attend, or vote at any member meetings.

The Board may extend an invitation to representatives of Associate member to join the Board as a voting member to better reflect the community.

Student NON-VOTING MEMBER

All students or post-doc fellows enrolled at an educational/research institution are eligible to participate in the Association training programs and selected industry events.
