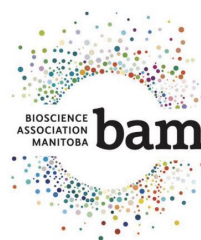

MEMBERSHIP CATEGORY

Business/Industry: Membership shall be limited to companies or individuals that are engaged in the research, development, manufacture, supply or sale of products, processes, or services, which are based on or provide support to the biosciences industry.

Associate: Membership shall be limited to persons or organizations devoted to the promotion of a cause or program, especially one of a public, educational, or charitable character, such as post-secondary institutions, teaching hospitals, research institutes and other not-for-profit agencies.

All the employees of business/industry members or associate members are eligible to participate in the Association training programs and industry events.
